Meet the ancient, and mysterious National Treasures of Peru, the Peruvian Hairless Dogs (PHD) *Chaska*, *Inti* and *Myrtle*! OK – you have probably noticed that *Chaska* (on the left) isn't exactly hairless – but she doesn't mind one bit, because PHD are to be found in both hairless AND coated varieties. Not only is *Chaska* an unusual coated brindle pattern, but she's also training very hard to become a therapy dog! If you see her in your travels, come over and say "Hola Chaska"!

The very noble and quite hairless *Inti* next to her, is very busy and proving quite consistent in the showing. Having won multi-R/Up in Group awards and Best in Group ribbons, and he was also crowned Dogonline (DOL) Rising Star All Breeds NT 2023, #1 PHD (Med) Show Dog of the Year and DOL Rising Star Competition Australia! Apart from being a dog of the underworld, he firmly upholds the PHD custom of cuddling humans because, according to legend, a 'living hot water bottle' after all!

Little golden girl *Myrtle* on the other hand, is very discerning and can be a little, breed typical, aloof until she knows you. She regularly demands her human slaves abide by the ancient customs that, when approaching her, everyone must do so barefoot, carrying a symbolic load on their back (a sign of submission) and no one is permitted to look into her eyes (although, just quietly, she can be easily bribed, with pats and treats)! Well – she is after all a 'Child of the Sun God' with her glorious copper skin - she truly is a 'golden dog' and a very privileged creature indeed! Also successful in the showing, *Myrtle* won the DOL National #1 PHD (Small) of the Year 2023, and the DOL National Breed Challenge and Rising Star Competitions!

### DID YOU KNOW?

- The PHD come in three sizes – small, medium and large, and in both coated and hairless varieties. The gene that causes hairlessness also results in the breed often having fewer teeth. All are born with a full set of puppy teeth, but these are not fully replaced by adult teeth, leaving the hairless PHD with varying levels of adult dentition.
- According to some, the PHD was introduced to Peru during the Chinese immigration. However, there is certain proof, such as representations on ceramics of different pre-Inca civilisations (*Vicus*, *Mochica*, *Chanca*, *Chanca* under *Tiahuanacoid* influence, *Chimu*), and in many cases the hairless dog has replaced the puma, the snake or the falcon. Subsequently, the PHD appears during the pre-Inca archaeological periods, i.e. between the years 300 BC and the years 1400 AD.
- In the time of the Incas, the PHD participated in ceremonies of worship to the lunar divinity and was rarely sacrificed. The black specimens in particular were considered as the "guides of the souls in their journey to the afterlife".
- In 1987 the tomb of *Lord of Sipán* was discovered in *Huaca Rajada* - accompanied by the skeletons of two concubines, eight servants and his beloved PHD.
- In pre-Hispanic times, the PHD was used for medicinal purposes, and Dr. Pedro Weiss, founder of the Cayetano Heredia University, discovered that the PHD presents ectodermal hypoplasia syndrome - meaning its skin is warmer and more sensitive than that of other dogs, reaching temperatures between 39C and 42C.
- Loyal, lively, alert, noble and affectionate, the PHD is a great watch dog, very athletic, and with few health problems, this unusual breed makes a super family member and devoted companion.

**Loss of Appetite**  
Reduced interest in food or refusal to eat

**Low-Grade Fever**  
A slight increase in body temperature

## DOGS AUSTRALIA: ATTENTION MEMBER BODIES AND SHOW SECRETARIES



## Attention Member Bodies and Show Secretaries

The following information has been received from the FCI Head Office.

Only FCI-NCO judges that appear in the FCI Judges Directory can judge at international FCI-CACIB shows i.e. **judges that are NOT listed in FCI Judges Directory CANNOT be invited to FCI international shows.**

The FCI Head Office insists that in case an authorization for a breed or group is **INCORRECTLY given** by an NCO to one of its judges (allowing him/her to judge and award FCI-CACIB ABROAD), the **FCI-CACIB proposals given by the judge will NOT be confirmed by the FCI Head Office.**

What does this mean for Australian Member Bodies and Clubs intending to contract judges from FCI NCO's (National Canine Organisations)?

From 1<sup>st</sup> August 2024 they must ensure that any judges from FCI Countries that they invite to officiate at CACIB Shows are in the FCI Judges Directory, otherwise the FCI will not confirm the CACIB awards as set out in FCI Show Regulations:

### 8. CONFIRMATION OF THE FCI-CACIB.

The FCI-CACIB proposals will be issued by the **appropriate judges**. The final confirmation will be done by the FCI. It is up to the FCI Head Office to check whether the dogs proposed comply with the conditions accepted for confirmation of the FCI-CACIB. The cards handed to the exhibitors at the shows duly indicate that the relevant dog has been proposed for an FCI-CACIB. They must read: "**Subject to confirmation by the FCI**". The FCI Head Office **must make sure that the FCI-CACIB was correctly awarded.**

### DOGS AUSTRALIA: UPDATES AND NEWS

#### → AMENDMENT: REGULATIONS - PART 5 CONFORMATION SHOWS.

**Dogs Australia Regulations Part 5 – Conformation Shows** has been amended in accordance with the June 2024 Special Board meeting minutes – refer **ITEM 5.1**.

These amendments are effective from **1 JULY 2024**.

#### → CONDUCT OF SPRINT DOG JUDGES TRAINING & ASSESSMENT PROGRAM.

In accordance with **5.3** of the June 2024 Special Board meeting minutes the approved Regulations for the Conduct of SprintDog™ Judges Training & Assessment Program effective from 1 August 2024 is now available from Dogs Australia website at: <https://dogsaustralia.org.au/.../rule.../regulations/>

#### → RULES FOR THE CONDUCT OF SCENT WORK TRIALS

In accordance with **7.7** of the June 2024 Special Board meeting minutes, amendments to **Rules 19.13 and 22.3.1** as below were approved and will be effective from 1 August 2024.

#### Current Rule (1 July 2024)

##### 19.13 - "Finish" calls

**19.13.1** - The "Finish" call is used in Classes that contain multiple hides (Advanced, Excellent, Master and Ultimate) and is required to stop timing of the search.

**19.13.2** - The handler is required to call "Finish" when all hides have been located for the search area or, for Classes/Elements with an unknown number of hides, when the handler believes that all hides have been located or a "blank room" cleared.

**19.13.3** - In the Advanced Class, if the handler fails to correctly call "Finish" within the maximum time allowed for the search or before leaving the search area precinct, the team will receive a Qualifying Fault and the maximum time allowed for that search.

**19.13.4** - In the Excellent Interior and the Master Classes, the number of hides in the search area is unknown. The handler must call "Finish" within the search time (including each area in multiple area searches). Failure to do so will incur a Non-Qualifying Fault.



**DOGS AUSTRALIA: UPDATES AND NEWS (continued)****22.3 Non-Qualifying Faults**

**22.3.1** - The following actions are deemed to be Non-Qualifying Faults:

(a) the maximum time for a search has been exceeded

(d) in the Excellent, Master and Ultimate Classes, where the number of hides is unknown, the handler does not call "Finish" before the expiration of the search time

**Amended To:**

**19.13** - "Finish" calls

**19.13.1** - The "Finish" call is used in Classes that contain multiple hides (Advanced, Excellent, Master and Ultimate) and is required to stop timing of the search.

**19.13.2** - In the Excellent, Master and Ultimate Classes, the handler is required to call "Finish" when all hides have been located for the search area or, for Classe/Elements with an unknown number of hides, when the handler believes that all hides have been located or a "blank room" cleared. The handler must call "Finish" within the allotted search time (including each area in multiple area searches). Failure to do so will incur a Non Qualifying Fault.

**19.13.3** - In the Advanced Class, if the handler fails to correctly call "Finish" within the maximum time allowed for the search or before leaving the search area precinct, the team will receive a Qualifying Fault and the maximum time allowed for that search.

**22.3 - Non-Qualifying Faults**

**22.3.1** - The following actions are deemed to be Non-Qualifying Faults:

(a) the maximum time for a search has been exceeded

(d) in the Excellent, Master and Ultimate Classes, the handler does not call "Finish" before the expiration of the search time

**→ SIRE AND DAM OF MERIT TITLES:**

At the Dogs Australia June 2024 Special Board meeting, it was resolved to approve the introduction of the following new titles:-

**DOM: Dam of Merit:** A bitch that has produced at least five (5) Conformation Champion offspring.

**SOM: Sire of Merit:** A dog that has produced at least ten (10) Conformation Champion offspring.

At least 1 of the conformation Champion titles (CH, GRCH, SUPCH, CIB, A2O) must have been awarded after the implementation date (01 January 2025).

Subsequently, Dogs Australia **Regulations Part 5 – Conformation Show** have been amended - effective from **1 January 2025** - as follows:

- **10.12** - Sire and Dam of Merit (Effective 01 January 2025)
- **10.12.1** - Sire of Merit (SOM) - A dog that has produced at least ten (10) Conformation Champion offspring.
- **10.12.2** - Dam of Merit (DOM) - A bitch that has produced at least five (5) Conformation Champion offspring.
- **10.12.3** - At least 1 of the conformation Champion titles (CH, GRCH, SUPCH, CIB, A2O) must have been awarded after the implementation date (01 January 2025)

**DOGS AUSTRALIA: UPDATES, AMENDMENTS AND NEWS (continued)**

→ **AMENDMENT: REGULATIONS PART 6 - THE REGISTER & REGISTRATION** - which currently reads:

**6.1.3** - No word that is in the nature of a known prefix or deceptively similar to a known prefix and no prefix except the breeders registered prefix may be used in a dog's name unless the following conditions apply:

**6.1.3.1** - The prefix of the new owner is permitted to be added at time of registration or transfer but must be added as a suffix and will be in addition to the thirty (30) letters or spaces as specified in **6.1.2** provided the dog has not been awarded a Dogs Australia recognized title, been bred from or used at stud.

**6.1.3.2** - The registered name remains unaltered with a preposition - e.g. 'of', 'to', 'from', 'with', 'at', 'is', 'by' - added followed by the new owner's prefix as a suffix. This new name after this point may not be further altered. In respect of dogs born in Australia, only dogs under one (1) year of age are eligible. Only one additional suffix may be added.

**6.1.3.3** - The consent in writing of all the owners of the second prefix must be given.

**6.1.3.4** - In the case of an overseas Kennel Name being used, all the owners must certify in writing that they are the owners of the Kennel Name and that it is registered with the appropriate overseas canine control.

**Be Amended to Read:**

**6.1.3** - No word that is in the nature of a known prefix or deceptively similar to a known prefix and no prefix except the breeders registered prefix may be used in a dog's name unless the following conditions apply:

**6.1.3.1** - One prefix registered with Dogs Australia may be added as a suffix at time of registration or transfer provided the dog:-

- (i) has not been awarded a Dogs Australia recognized title, and
- (ii) has not been bred from or used at stud, and
- (iii) is under one (1) year of age if born in Australia.

**6.1.3.3** - The consent in writing of the breeder and all owners of the suffix must be given.

**6.1.3.2** - The registered name remains unaltered, and a preposition (eg, 'of', 'to', 'from', 'with', 'at', 'is', 'by') followed by the new owner's prefix as a suffix is added to the original name. The new name after this point may not be further altered.
